RESOLVES:

ARTICLE 1°.- Be established that, until the date in which at least TWO (2) Accredited Laboratories have been duly authorized to carry out tests based on the technical standard ENACOM-Q2-61.03 V17.1 "Terminales de Usuario de los Servicios de Comunicaciones Móviles" approved by Resolution ENACOM N° 5.762/2017, dated December, 26 of 2017, the Authority will accept a Declaration of Conformity in cases where there is no coincidence in the allocated bands, as indicated in ANNEX "Declaration of Conformity", registered in the ELECTRONIC GENERATOR OF OFFICIAL DOCUMENTS as IF-2019-07372506-APN-DNPYC # ENACOM, which forms an integral part of this publication. When there is a coincidence of allocated bands the provisions of Article 4 of ENACOM Resolution No.

5762/2017 (modified by ENACOM Resolution No. 4709/2018) will apply.

ARTICLE 2°.- Be informed that, for the renewal of applications done under the conditions established in the preceding Article a Test Report must be submitted, issued by an ENACOM accredited Laboratory enabled for the corresponding measurements.

ARTICLE 3°.- Communicate, publish, give to the NATIONAL DIRECTORATE OF THE OFFICIAL REGISTRY and when completed, file. Silvana Myriam Giudici

**DECLARATION OF CONFORMITY**

The Declaration of Conformity, mentioned in Article 1 of this administrative act, is the written document by means of which the manufacturer or its local representative, registered as such in the Register of Activities of RAMATEL (Resol. ENACOM N° 8967/16) , declares that the device fulfils the requirements established in the ENACOM-Q2-61.03 standard.

The minimum data to include in the Declaration of Conformity are the following:

- Name and address of the manufacturer or its local representative established in Argentina
- Description of the product (detailed enough so that it is easy to identify the specimens covered by it: brand, model, etc.).
- Reference to compliance with the ENACOM-Q2-61.03 standard.
- Identification of the signatory (name, surname and position). Date.
